(3) SYLLABUS

The course examines the relationship between archaeology and numismatics along with the importance of coins as archaeological evidence for the interpretation of the past. Discussion covers among other matters types of archaeological evidence based on archaeological theory, numismatic terms and methods, data use and research directions. Attention is given to four sub-categories of archaeological-numismatic evidence: coin hoards, inauguration deposits, sporadic excavation coin finds and burial coins, while the significance of the coin as an artefact and a carrier of contemporary art is analyzed. All the above are examined through case studies, also including selected coinages of cities or wider areas of the southeast Mediterranean within the general context of the history, art and culture of the region. The course approaches the role of coins not only as a means of commerce, but also as parts of history, archaeology and art in time and space.
